Exploring Wildfire Scars

(Editor)

This month's Crozier Fire, in El Dorado County near Quintette, has burned over one of the more productive quartz crystal areas in the region, clearing the brush for us rockhounds. Wildfire scars can be excellent collecting areas for the first couple years after the fire, until grasses and underbrush have started growing back. The heat of the fire will also crack cobbles open for you, allowing quick and easy inspection for minerals within the quartz, such as gold.

But there are dangers involved; do not enter a recent burn unless you are prepared to walk off-trail in treacherous conditions. And if you do get hurt, please don't sue our club for this article or the Forest Circus for allowing you access.

Root fires are real, acting as underground conduit for the flames. As the flames follow underground roots, the



ground collapses overhead, sometimes creating thinly-covered pit traps with hot embers at the bottom. Tall, leather boots are best at preventing such accidents. In the graphic, above, you can see the trap, just waiting to catch you! Stay away from big stumps.

Children and dogs don't understand the concept of root fires, so keep them close to you, or consider leaving them at home.

Don't touch any standing trees! Nevermind the soot you'll get on yourself, there is a real danger of any burned tree out there falling over. Just assume that any tree you touch will fall. This danger seems to be worse a year after the fire, and continues for several years thereafter. When driving in such an area, always have a chainsaw with you, and assume that a tree may fall down on the road behind you, blocking you in. (I've had this happen twice, but I do carry a saw.)

Newly-fractured quartz, exploded by the fire's heat, is wickedly sharp! Be careful when handling it. Hillsides and talus fields will be unstable as things tend to be lubricated by the ash and loss of plant material.

Also obey any temporary closure orders issued by the Forest Service. They close the forest after fires to prevent additional damage to the roads, and to prevent tourists interfering with rehabilitation of the burn area. Don't pick up any brass fittings the firefighters left behind; they'll be back for them. Yield to heavy equipment, don't get in the way! Pro tip: if you want to blend in, wear a Nomex shirt and wave at everone you see. Put a hard hat on your dashboard, even, and cones around your bumper when you park. You must be official, with those cones!

Members present: 25, guests present: 2




